

Convention Sales Room Policy

The Golden Glow of Christmas Past* (GGCP*) Convention Sales Room (SR) Policy outlines responsibilities and conduct required of a Seller, Assistant and the Vetting Committee. All parties must adhere to the following requirements to sell, vet, and resolve any concerns during the SR event. Thank you for honoring this policy.

- 1. Only the Seller and one (1) designated Assistant are permitted to sell. Both must be GGCP® members, registered for the convention, and wearing convention badges during SR schedule.
- 2. Seller will receive the set-up/vetting/sale schedule prior to the convention which Seller must follow.
- 3. After setup and vetting have been completed, the final 30 minutes prior to the Sales Room doors opening to the general membership will be reserved for Seller buying/selling. Buying/selling prior to the last 30 minutes will not be permitted.
- 4. The Vetting Committee will consist of at least three (3) GGCP* members selected by the SR Chair and they must wear Vetting Committee badges.
- 5. Items offered for sale must fit into at least one (1) of the following categories and be made or manufactured in compliance with the rolling 40-year rule in the GGCP® Bylaws.
 - Only Christmas-related items (no other holidays permitted).
 - Toys, books, or games that would be used at Christmas.
 - Patriotic items that would be used as Christmas decorations.
 - · Candy containers with Christmas-related themes only.
 - Putz/Christmas Garden items.
 - Books, publications, or articles containing Christmas info pertaining to the rolling 40-year rule in the GGCP® Bylaws.
- 6. In accordance with the GGCP® Code of Ethics, all items must display visible price tags and be labeled to disclose any repairs, alterations or being sold "as is."
- 7. The Vetting Committee and Seller/Assistant must conduct themselves in a polite, respectful manner, and act within the guidelines of the GGCP® Code of Ethics. If the Vetting Committee identifies an item not adhering to the requirements in #5, the Committee will remove it from the sale. An item not adhering to #6 must be corrected to remain in the sale.
- The Seller has the right to discuss the concerns(s) with the Committee to resolve the concern(s).
- 9. The final decision to remove or keep the item(s) in question in the sale will be determined by a majority vote of the Vetting Committee.
- 10. Any item identified as not fitting into the categories outlined in #5, must be placed out of sight (not available for sale) by the Seller and/or Assistant, for the duration of the SR event.
- 11. Refusal to honor any of these rules will be due cause to be barred from selling in future Convention Sales Rooms. Reentry will be determined by a majority vote of the Board of Directors
